## **Re:** Notice of Practice Closure Termination of Physician-Patient Relationship

Dear Valued Patient and Family:

It has been an honor and privilege to have been your health care provider, some of you for many years. I am grateful for the opportunity to have served your medical needs.

Effective 8/30/2024, **The Milestones Center, LLC** ("the Practice") will be closing our office located at 65 Mechanic Street, Suite L 3, Red Bank, New Jersey 07701 (the "Office"). We will provide telemedicine visits for established patients only until 9/27/2024. As a result, the Practice is providing notice to our patients of the closure and the termination of our medical services. Due to the closure and termination of our medical services, our physician-patient relationship shall be terminated effective 09/27/2024. Prior to 09/27/2024, we shall continue to provide you with all necessary medical services and emergency care. Note that the provision of such services shall not evidence any intent to re-establish a physician-patient relationship.
